(SANTA BARBARA, Calif.) – Santa Barbara County Registrar of Voters Joe Holland would like to remind eligible candidates that the deadline to file a Declaration of Candidacy is 5 p.m. Friday, August 10. Candidates who have been issued candidate filing paperwork must complete his/her Declaration of Candidacy by 5 p.m. on August 10 in the office of the elections official to be qualified as a candidate.

Declaration of Candidacy: July 16- August 10, 2018

Eligible candidates must be registered voters of the district, trustee area or division, if applicable. All candidates **MUST** file a Declaration of Candidacy in person and meet Nomination requirements between July 16, 2018 and 5 p.m. August 10, 2018 to qualify for the Consolidated General Election.

Declaration of Candidacy Extension Period: August 11-August 15, 2018

If an eligible incumbent fails to file a Declaration of Candidacy and meet the Nomination requirements by 5 p.m. on August 10, 2018, a five-day extension is allowed for any person, other than the incumbent, if otherwise qualified, to file for the office.
