D. Award Procedures.

Following scoring and evaluation by the Evaluation Committee, a Notice of Intent to Award will be issued. A contract, in form and content similar to *RFP Exhibit F*, will be negotiated with the selected Bidder(s). The final contract(s) will be submitted to the County Board of Supervisors for review and approval. It is the intent of BeWell to have contract(s) in effect by ~~January 1, 2021~~ **March 1, 2021**.
