Directions

Directions to St. Vincent's:

From Santa Maria:

101 South to State Street Exit (the exit after Turnpike). Stay in left lane-turn left at light. (There are two left lanes, stay in the right left lane.) Go to next light at the intersection of State Street & Hwy 154 and turn left ONTO Highway 154 . You should be in the right lane.

Once you pass over the freeway (101), turn right at the light on to Calle Real. Continue to Pesetas lane and turn left. Continue to La Colina and turn left. Continue to Verano Drive and turn left. You are at our back gate. The first building is Administration. You may proceed up the road to the Sister's house. **DO NOT GO DOWN THE TEMPORARY ROAD. YOU WILL WIND UP AT THE POOL AND THE CHILDREN'S CENTER.**

From Santa Barbara:

101 North to 154 exit. Stay in right lane. Cross the light (State Street). Continue to Pesetas Lane and turn right. Continue to La Colina and turn left. Continue to Verano Drive and turn left. You are at our back gate. The first building is Administration. You may proceed up the road to the Sister's house. **DO NOT GO DOWN THE TEMPORARY ROAD. YOU WILL WIND UP AT THE POOL AND THE CHILDREN'S CENTER.**
