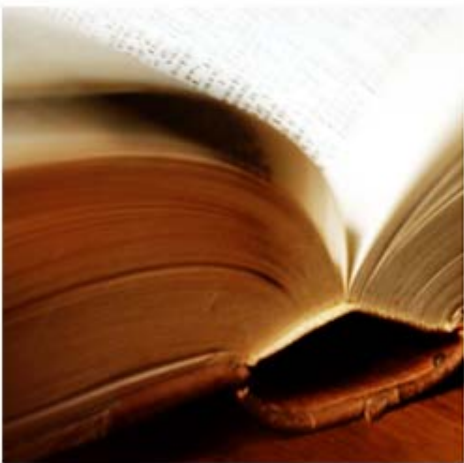

- Review & comment on Targeted Advocacy planks.

Dec. 2<sup>nd</sup>-BoS

- Initial Review of Draft 2015 Legislative Platform.

Jan. 13<sup>th</sup>-BoS

- Consider & approve 2015 Legislative Platform.
