**NOTES ON OTHER DEPARTMENT FEES:**

- Fixed Fees are non-refundable.
- If there is more than one fixed fee, only the largest fixed fee will be collected for Flood and Water; for all other departments all fixed fees will be collected for each permit type.
- Projects located in Montecito: no Fire fees
- Conditional Use Permit in existing building within urban area: collect for County Counsel, Fire, & \*EHS if well/septic
- Lot Line Adjustment with no potential structures or building potential: no Road and \*EHS fees
- Minor Conditional Use Permits when structure exists & CUP is just for use and for fences and walls: no \*EHS fees
- CDPs with hearings for additions with public water and sewer: no \*EHS & Parks fees
- County Counsel & \*EHS reserve the right to charge additional fee if estimated costs are exceeded. \*EHS hrly rate will be applied (\$161.00/hr)
- Water fee collected only if storm water treatment control BMPs required.
- County Fire fee or Carpinteria/Summerland Fire District fee will be assessed based on parcel location, if applicable.
- Collect \$255 for EHS if review is necessary and no fee is listed. \*EHS hrly rate will be applied (\$161.00/hr.)
- Surveyor tentative final map fee based on number of lots: **1-25 lots = \$1,132 / 26-75 lots = \$1,266 / 76+ lots = \$1,454**
