There was a general discussion of staffing needs with regard to embarking on more alternative investments. Mr. Rue suggested that if additional products were elected, the Board should be prepared to have at least one staff person to monitor private equity, real estate and absolute return efforts. Lacking that, he recommended that the Board consider only “turnkey” products to simplify administration.

There was also discussion regarding where funds would be pulled from in order to fund any new initiatives. Mr. Rue suggested a pro-rata approach.

Trustee Terris made and later withdrew a motion directing the retirement office to contract with PCA to conduct an asset liability review.

Chair James directed PCA to return with a written asset liability study proposal.

There was an overall consensus among the Trustees that having an intensive workshop focusing on a singular investment topic had worked very well. Trustee Gray requested that staff write letters to the various managers that participated in the Portable Alpha Tutorial Workshop thanking them for their excellent presentations.

Chair James directed staff to arrange a second, comprehensive, visit from Arden Asset Management.

Trustees Terris and Gallas reminded staff of their interest in International Real Estate Investments. Additionally Trustee Terris expressed an interest in all forms of Alternative Investments.

The Board thanked Mr. Rue, Ms. Bernstein, and staff for an excellent retreat.
